

SUBJECT OF THE PROPOSAL

The subject of the Proposal for the Competition is the Development of the Conceptual Urban and Architectural Design of the Promenade in the "Budva Shell", Part of the Budva-Bečići Promenade, Phase I

AIM OF THE PROPOSAL FOR THE COMPETITION:

The main aim of the Proposal for the Competition is the selection of the best conceptual urban and architectural design for the promenade in the municipality of Budva, which will serve as the basis for elaboration through the main project followed after the selection of the first-awarded competition proposal work.

MEMBERS OF THE JURY AND REPORTERS

A competition jury consisting of 7 (seven) members was appointed by the decision on announcement for a proposal for the competition for the development of the conceptual urban and architectural design of the promenade in the "Budva Shell", part of the Budva-Bečići Promenade, phase I number: 01-082/22-2428/1 dated November 25, 2022:

JURY JUDGING INFORMATION:

According to the *report on the received proposal works*, the jury stated that they received 39 proposal works for the competition under the codes: 00100, 00125, 02010, 08033, 08188, 10854, 11235, 11977, 12088, 12368, 12421, 12529, 13579, 15050, 15308, 16019, 17118, 19421, 20322, 20546, 21117, 22013, 22888, 32023, 38388, 45669, 57862, 58246, 58745, 61323, 61989, 71290, 71717, 74564, 85310, 87431, 88888, 96589, 97531.

As prescribed by the Rulebook on the Manner and Procedure of Announcing and Conducting a Public Competition for Conceptual Urban and Architectural Design, on March 8, in the presence of the president of the jury, the reporters opened, reviewed, and classified the submitted proposal works. The reporters took the envelopes marked "AUTHOR INFORMATION" for the purpose of safekeeping.

The jury reviewed the content of the coded proposal works submitted in a timely manner: 00100, 00125, 02010, 08033, 08188, 10854, 11235, 11977, 12088, 12368, 12421, 12529,

13579, 15050, 15308, 16019, 17118, 19421, 20322, 20546, 21117, 22013, 22888, 32023, 38388, 45669, 57862, 58246, 58745, 61323, 61989, 71290, 71717, 74564, 85310, 87431, 88888, 96589, 97531.

The jury worked all the time in a complete composition, respecting the guidelines of the Rulebook on the Manner and Procedure of Announcing and Conducting a Public Competition for Conceptual Urban and Architectural Design and the Decision on the Announcement of the Proposal for the Competition in question.

WORK COURSE OF THE JURY

The full jury sessions were held on 17.03., 18.03, 19.03 and 02.04.2023 in the premises of the Manager of the Municipality of Budva.

First block of jury judging:

At the first block of jury judging, held on 17.03. 18.03. and 19.03., the review and classification of the submitted proposal works was carried out.

The jury reviewed the content of the proposal works submitted in a timely manner under codes: 00100, 00125, 02010, 08033, 08188, 10854, 11235, 11977, 12088, 12368, 12421, 12529, 13579, 15050, 15308, 16019, 17118, 19421, 20322, 20546, 21117, 22013, 22888, 32023, 38388, 45669, 57862, 58246, 58745, 61323, 61989, 71290, 71717, 74564, 85310, 87431, 88888, 96589, 97531.

The inspection of proposal works was carried out in four rounds.

In the first round, the following proposal works were eliminated: 00125, 08033, 08188, 12368, 12529, 13579, 22013, 22888, 38388, 61989, 85310.

In the second round out of 28 proposal works, the following proposal works were eliminated: 10854, 11977, 12088, 15050, 17118, 20322, 20546, 21117, 57862, 58745, 61323, 71290, 88888, 96589.

In the third round out of 14 proposal works, the following proposal works were eliminated: **02010**, **11235**, **12421**, **15308**, **16019**, **19421**, **45669**, **71717**.

The proposal works entered the final round are: 00100, 32023, 58246, 74564, 87431, 97531.

After inspecting the technical documentation of the 6 works that entered the final round, the jury decided that the conceptual designs of the above-mentioned proposal works were shortlisted for the award with corrections in relation to the jury's comments, in accordance with the preliminary report and according to Article 35, paragraph 3 of the Rulebook on the Manner and Procedure of Announcing and Conducting a Public Competition for Conceptual Urban and Architectural Design ("Official Gazette of Montenegro" No. 19/2018 dated March 28, 2018, entered into force on April 5, 2018).

At the session held on April 2, 2023. in the full composition of the jury and in the presence of the reporters, it was decided that the proposal works that were shortlisted for the award (00100, 32023, 58246, 74564, 87431, 97531) WOULD BE RETURNED

FOR DEVELOPMENT according to the jury's comments and would be submitted within 45 (forty-five) days from the public announcement of this report, on 27.05. 23:59 (UTC+1) after which the jury would meet in full, in the presence of the reporters, and make a final decision on the distribution of awards.

Upon the decision of the jury, the Proposal for the Competition will continue as an extended competition; according to Article 35, paragraph 3 of the Rulebook on the Manner and Procedure of Announcing and Conducting a Public Competition for Conceptual Urban and Architectural Design ("Official Gazette of Montenegro" No. 19/2018 dated March 28, 2018, entered into force on April 5, 2018).

Upon the decision of the jury, within the funds of the award fund, the established awards will be granted in accordance with the final report and distribution of proposal works; according to Article 35, paragraph 3 of the Rulebook on the Manner and Procedure of Announcing and Conducting a Public Competition for Conceptual Urban and Architectural Design ("Official Gazette of Montenegro" No. 19/2018 dated March 28, 2018, entered into force on April 5, 2018).

The second and final block of jury judging will be held no later than 14 (fourteen) days from the delivery of the decision, corrected in accordance with the jury's comments.

The final jury report will be published no later than 14 (fourteen) days after the final jury session.

The payment of monetary awards will be made 30 (thirty) days after the public announcement of the final report of the jury.
